

ONE-YEAR CONTRACT FOR DRIVER'S EDUCATION AT DAKOTA HIGH SCHOOL 2024-2025 SCHOOL YEAR

One-Year Contract for Driver's Education Instruction

In exchange for the fees outlined below, DRIVE-RIGHT School of Driving, Inc. agrees to instruct students of Dakota High School in a driver education course. The full program will consist of 30 hours of classroom instruction, 6 hours of behind-the-wheel instruction and 6 hours of observation.

COST OF COURSE PER STUDENT:

\$500.00 Full program (classroom and behind-the-wheel). The total fee does reflect a discount versus a student enrolling for the full program independently through Drive-Right.

\$209.00 Classroom only (if a student has completed the behind-the-wheel portion elsewhere). \$400.00 Behind-the-wheel only (if a student has completed the classroom portion elsewhere).

\$1,000.00 Instructor travel time per enrolled class.

\$70 charge per behind-the-wheel lesson completed, if the student does not complete the entire behind-the-wheel requirements.

BEHIND-THE-WHEEL:

Once the classroom portion begins and the students obtain their permit, they are free to schedule driving lessons directly with the instructor. Scheduled drives will begin and end at Dakota High School. Drives may also be scheduled on non-school days, Christmas break and Spring break etc. Students will receive 6 hours of driving and 6 hours of observation. A 24-hour notice is required for any behind-the-wheel cancellations. Cancellations with less than 24-hour notice or not showing up for a driving lesson will result in a \$25.00 missed lesson fee charged to the parent/student.

CLASSROOM REQUIREMENTS:

Students will follow all Dakota Handbook Rules and Regulations when attending Drive-Right classes. The class schedule and class start dates will be mutually agreed upon by both parties. All classes (including a summer school class) must have a minimum enrollment of 25 students. Classes without minimum enrollment will be cancelled two weeks prior to scheduled start date. If minimum enrollment is not met, Dakota High School may request that Drive-Right consider an exception based on circumstances.

DRIVER EDUCATION:

Drive-Right agrees to offer and provide driver's education classes to Dakota students on Dakota High School's campus. Drive-Right shall be solely responsible for planning and presenting the driver's education requirements imposed by the State of Illinois. Drive-Right shall provide all necessary teachers and substitutes. All driver's education teachers or substitutes shall be considered employees of Drive-Right and not employees of Dakota High School.

TERMINATION:

Thank You.

This agreement may be terminated by either party, without cause, upon one semester's advanced written notice. Written notice must be given prior to the beginning of the semester to be effective at the beginning of the following semester. This agreement may be terminated by Drive-Right if loss of certified driving instructor occurs (for any reason) with no advance notice required to Dakota High School. Certified instructor is defined as one that has educational credentials required by the state of Illinois and approved to teach in the public school system.
